Mansfield Dairy Terms and Conditions

- 1. Payment Full payment is to be received no later than 7 days from invoice date.
- 2. Late Payments If payment is not received by the due date, interest may be periodically levied on overdue amounts (interest rate determined by reference to Section 2 of the Penalty Interest Rate Act 1983) until the account is paid in full.
- **3.** Credit Facilities these may be withdrawn without prior notice should an account become overdue or if payment is made by a dishonoured cheque.
- 4. Change of Ownership Mansfield Dairy must be immediately notified in writing in the event of any change in ownership of the business. The Customer agrees to indemnify Mansfield Dairy against any loss incurred if such notice is not given. Note: Credit facilities will not automatically transfer to the new owner.
- 5. Credit Limit Mansfield Dairy from time to time may vary the credit limit it will allow to the Customer.
- 6. **Debt Collection** the Customer agrees to reimburse Mansfield Dairy for any additional expenses (including legal costs, commissions, and bank charges) incurred in collecting outstanding debts.
- 7. The Customer agrees not to deduct any amount from an account due to a dispute of the account or the quantity of goods received. The Customer agrees that once the goods are accepted as being delivered and received, the quantity of goods received cannot be disputed.
- 8. The applicant hereby declares that they (or any partner, or Director of same) has never been registered under the Bankruptcy Act or been a Director of a company which has gone into liquidation or had a receiver / manager appointed.
- **9. Credit Facilities** are extended to the Customer on the basis of the above terms and conditions. These terms and conditions may be varied from time to time by Mansfield Dairy by notice to the Customer.

Privacy Act

If Mansfield Dairy considers it relevant to assessing the Customer's application for commercial credit, the Customer agrees to Mansfield Dairy obtaining from a credit reporting agency a credit report containing personal credit information about the Customer in relation to commercial credit provided by Mansfield Dairy

If Mansfield Dairy considers it relevant to collecting overdue payments in respect of commercial credit provided to the Customer, the Customer agrees to Mansfield Dairy receiving from a credit reporting agency, a credit report containing personal information about the Customer in relation to collecting overdue payments.

The Customer agrees that Mansfield Dairy may give to and seek from any credit providers that may be named in a credit report issued by the reporting agency information about the Customer's credit arrangements. The Customer understands that this information can include any information about his/her credit worthiness, credit standing, credit history or credit capacity that credit providers are allowed to give or receive from each other under the Privacy Act.
